1. CDCA and Military Spouse Licensing Update

CDCA continues working on behalf of our California's defense installations, military members and local communities in order to make progress on critical issues as we all adapt to the continuing challenges. CDCA will pursue actions that can help our communities and military families through reciprocal licensing for those already licensed by other state's licensing or certifying agencies.

The 2019/2020 State Legislative session adjourned August 31, 2020. The majority of advocacy organization's priority bills failed due to a de-prioritization of many bills that were not related to COVID-19. The number of bills submitted in 2020 was down about 15% from 2019. The Governor vetoed about 15% of the bills reaching his desk.

We will proceed during the upcoming legislative year to advocate for reciprocal licensing. The Regular Session convenes for the Organizational Session on December 7, 2020.

Data you may hold or be able to obtain including anecdotal experiences help build the arguments in favor of legislative actions. Licensing and certifying agencies need to know that lengthy procedures, arbitrary requirements and yet more duplicative testing has a negative impact on families but also state readiness and response in emergency situations. Request current data from your local military facility to help with metrics on the problems with spouse licensing and employment.

2. The Positive Economic Impact of Military on Our Communities

Communities with a strong military presence have the financial benefit of stable revenue while communities with a dependency on travel, tourism, conventions and related spending face unprecedented revenue challenges for local government and citizens. You can reinforce the financial contribution of military salaries, spending and investment in your communities. A state impact report is available. Member organizations continue to assess their own communities.

2019 National Security Economic Impact in California

The *California Statewide & Regional National Security Economic Impacts* report on federal national security spending was released by the State of California. The California Research Bureau of the California State Library prepared the report for the Governor's Office of Planning and Research and the Governor's Military Council. The report relies primarily on data from the Department of Defense, Homeland Security and Veteran's Affairs.

The report says that national security's economic impact is similar to high profile sectors like agriculture and the film industry.

The federal government spends at least \$49 billion dollars and directly employs approximately 330,000 residents in the state. This results in \$167 billion in economic impact and support more than 795,000 full time equivalent jobs in California. Economic activity occurs in every region of the state, from major coastal areas like San Diego and Los Angeles to small, inland communities, like Bridgeport, El Centro and Ridgecrest.

San Diego Military Advisory Council (SDMAC) Military Economic Impact Report

SDMAC partnered this year with the Rady School of Management at UC San Diego to produce their annual economic report of the military in the San Diego region. These reports independently highlight the significant impact the presence of our military has upon our region's economy.

SDMAC's Research Committee, led by SDMAC Board member Mark Wernig from Dowling & Yahnke, managed the report, including facilitating the data collection from our local military.

3. CDCA meetings and outreach in the 2020 environment

Regional Defense Partnership collaborates on virtual events and conferences

RDP-21 is now holding the monthly general (open) meetings via Zoom Webinar. The migration allows information sharing and communication needs to be met. Conferences are also successfully migrating to on-line meetings.

The Advanced Naval Technology / Coastal Trident Exercises is one of the nation's largest regional asymmetric threat training exercises and typically occurs along the coast of Southern California every spring. This year, in the middle of planning for the event the military base, industry partners, and community participants were confronted with a real asymmetrical threat—the coronavirus pandemic and related restrictions that put the event at risk. The event was successfully migrated to a webinar format.

RDP-21 will complete this year collaborating on conferences with the Port Hueneme Division, Naval Surface Warfare and Naval Facilities Command Expeditionary Warfare Center (NAVFAC EXWC) with the hosting of an Innovation Discovery Event (IDE) this month and as a partner supporting the conduct of next month's More Situational Awareness for Industrial Control Systems (MOSAICS) Joint Capability Technology Demonstration Industry Day scheduled for November 4 and 5. Overall, the common thread between all these events focus is the development of military capability through technological innovation and collaborative partnerships.
